The parents will be afforded the opportunity to discuss the current accreditation status of the school and review the school improvement plan for the current school year at the first PTO meeting held each year. Subsequent PTO meetings are held to discuss student progress, programs offered, and school improvement updates.

- 4. Southside Elementary School will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs by:

Parents will be sent monthly copies of the newsletter, Early Years and Nutritional Nuggets. These newsletters provide information to help promote the home-school connection.

Parents will be invited at a minimum of twice per year (fall and winter) to parent-teacher conferences so that they will be informed as to the academic, social and emotional growth their child demonstrates.

B. The school will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

- Read Across America focuses on reading and provides books and information for parents on working with students in reading at home.
- STEM Day focuses on math and science and provides information and ideas for parents in working with students in these content areas at home.
